


# KUDOS

#### RADIOLOGY

Seminole Hospital District received our 3-year recertification as a *Certified Mammography Facility through the State of Texas* through September 2026. #### **IT Security and YOU**

Between 21 October 2009 and 31 December 2022, 5,150 data breaches involving greater than 500 individuals were reported to the Office of Civil Rights (OCR). Between 2009 and 2015 loss/theft of healthcare records and electronic protected health information dominated the breach reports. However, since 2015 hacking/IT incidents have dominated the breach reports. In 2022 there was an increase in cyberattacks and data breaches at business associates.

382,262,109 individuals have been affected by data breaches from 2009 to 2022. In 2018, healthcare data breaches of 500 or more records were being reported at a rate of 1 per day. In 2022, an average of 194 data breaches of 500 or more records were reported each day.

You, an employee of Seminole Hospital District (SHD), play a very important role in keeping our systems secure. You are the **most important piece** of the SHD IT Security System. IT Security can implement all the technical wizardry known to man, but if you open an infected email, click on a link, or provide your credentials, you have opened the door and invited the bad guy into our systems. Hence the reason you always hear: DO NOT open suspicious emails, click on links, or provide your credentials to ANYONE through email, on the phone, or any other way for that matter. No credible individual will ask you to share your username and password.

> "There's no silver bullet to security. And for email, it comes down to the user."

#### **BOARD MEETING**

Seminole Hospital District held its regular board meeting on Tuesday, September 26th.

Attendance was high as both community members and District staff waited for answers to recent changes at SHD, namely September's reduction in force and the revelation of SHD's financial situation. The Board welcomed guests with a very open dialogue.

Staff members who spoke demanded to know what had happened to the financials, when it occurred, why it took so long for anything to be done, and requested a better understanding of the current course of action.

Jay Youngblood, President of the SHD Board, stated his appreciation of those who spoke during the open forum before he addressed their concerns. Mr. Youngblood stated that it has "been a collection of things ... and it has taken over a period of time." Jay spoke about how the building project significantly reduced the reserves of the Hospital, that was followed by Covid expenses, and inflation. Those issues were compounded with the developing billing issues that were not addressed over a period of years. Despite the best intentions of Board Members, the District is now in its current financial position. [The Board] "tried to bring in people that were talented to fix the issues to avoid this situation.

Addressing a staff concern that quality of care might diminish and the District begin to favor a more for-profit approach, Jay Youngblood explained, "What we're looking to do is not become a corporate hospital that is a forprofit organization that rewards shareholders. What we're looking to do is to develop a district that is a sustainable district."

Albert Pilkington, District CEO, clarified "we're 75-80% through the process." Following productivity analysis, Mr. Ovation Health's Pilkington and SHD Directors initiated a reduction in force as well as a review of all contracts which will save SHD around \$180,000 each month. Going forward, Mr. Pilkington is observing to determine if the reduction in force was successful. Now the focus will be on repairing and bolstering the financials. Mr. Pilkington will be working closely with the incoming Director of Revenue Cycle, Mr. Barry Dalton who is set to begin at the District in October October.

The Board ended open session by reminding guests that they are seriously concerned about the employees and the District,

# **IT & INFORMATICS**

Spooky season is upon us - but I don't mean Halloween! October is Cybersecurity Awareness Month.

Computer hackers, cybersecurity breaches, and identity theft are certainly scary. How do you stay safe from online threats? Remembering these few guidelines can help you stay safe.

· Use a strong password consisting of at least 12 characters, mixed case letters, numbers, and special characters.

· Do not click on links, attachments, or buttons in emails unless it is something you were expecting to receive. Even someone you know could have their email spoofed so

Just knowing the person is not enough.
Always take the time to verify the legitimacy of an unexpected email through a trusted source of contact.

Use multifactor authentication (MFA) whenever possible. Additionally, if you ever work remotely (off-site) make sure to tell IT so that we can get you going with SHD's MFA.

 Inspect web addresses for legitimacy before visiting a website. Hackers can easily set up a malicious, look-alike website designed to steal your information. A good rule of thumb is to avoid websites that say "Ad" or "Sponsored."
